We the people as citizens, business owners, and inhabitants of the United States of America; a nation that prospers from its diversity, economic and political system; mutually seek a resolution from this 118th Congress, under the authority given to it by the people; to assess and legislate 'America First Standards' addressed herein; as a means to revitalize the nation's manufacturers and allied industries; and prioritize pro-American standardization over the inconsistencies of foreign and "international standards."

Although standards on a global scale may have their place in some arenas; all global standardization lacks an obvious allegiance to the United States, with no accountability to the American people; and the primary benefactor being foreign organizations with 'globalist' agendas; including The World Economic Forum (WEF), The World Trade Organization (WTO), and The International Organization for Standardization (ISO); which are all allied organizations headquartered in Geneva, Switzerland.

In contrast, America First Standards was developed exclusively to revitalize the manufacturing sector of the United States; increase the global competitiveness of U.S. businesses, and facilitate economic growth; with an emphasis on pro-American values; that is, to live free and independent, as entitled under the laws of the land, the Laws of Nature and of Nature's God.

Let it be clear, the standards presented here is intended to unite the country behind an 'America First' political and economic movement; one that utilizes government resources efficiently; to work for the people; to enable businesses to prosper; strengthen the nation's economy, and repair the people's confidence in their government.

Further, leading economist, independent of political affiliations, agree on the dangers of Globalization; including 'new world orders' and the hypocrisies of non-regulatory standards masquerading as "necessities" for a moral cause. For these compliance policies are 'gaslighting' the public with misleading non sequiturs to weaken the independence, liberty and competitive advantages

of the United States. Therefore, to counter these threats on a national scale, America First Standards has been made available for all Americans to download free-of-charge at www.AMCAcert.com/congress.pdf and additionally, shall be made accessible by order of Congress on the National Institute of Standards and Technology (NIST) website; enabling businesses nationwide, in all states, and all sectors to benefit from pro-American standardization.

To prove this, let the following 'standards' be analyzed by this Congress; standards that are free of political party bias, free of prejudices, and free of corporate cronyism:

- Government shall provide improved incentives in relation to the 'Buy American Act' for manufacturers compliant to 'America First Standards' for utilizing at least a portion or primarily; raw materials, equipment, tools, and/or supplies made in the United States.
- Government shall invest in worldwide public relations and advertising campaigns; including social media to ensure 'Made in the USA' is internationally recognized as the highest quality in the world; as to unilaterally promote America's manufacturers as the 'gold standard' in manufacturing worldwide.
- Government shall prioritize federal contracts to establish 'joint ventures' with manufacturers and other businesses expanding into or investing in America's struggling communities; in particular the once thriving 'mill towns' that peaked in the 1950's and has been in decline since; which severely impacted the working class primarily in, but not limited to the Northeast and Midwest regions of the United States. The contracts shall incentivize the creation of new businesses in high-tech, industrial, and construction sectors; rebuild infrastructure, modernize the region's energy capabilities, and provide well-paying jobs to reinvigorate these once booming, working class towns.
- Government shall establish specialized funding programs or grants for state and public universities employing

pro-Capitalist professors; a rarity amongst educators today; to ensure students learn both the positives and challenges of America's economic system; as an alternative to the socialist, left-leaning curriculum students have been subjected to for decades. These government-backed incentives shall prioritize schools lecturing on the criteria and significance of competitive markets, voluntary exchange, capital accumulation, innovation, property rights recognition, wage labor, entrepreneurship, value pricing, and a fair regulatory system.

- Government shall expand the Small Business Administration (SBA) to fundamentally and more efficiently support America's small businesses; improve training of SBA employees, to provide more robust financial assistance programs, especially for growing companies and start-ups launching world-changing inventions; such as products that improve the lives of Americans, the planet, and society as a whole.
- Government shall redirect funding from the billions of dollars wasted on special interests groups, lobbyist, unelected bureaucrats; and utilize the funds to inspire and support Americans in the field of entrepreneurship, product development, and the skilled trades of machining, fabrication, metalworking, and other custom manufacturing; as well as job shop services, engineering, lean manufacturing, renewable energy, natural gas, and the green-friendly mass production of industrial and consumer goods.
- Government shall 'reform' the International Trade Administration (ITA) to more effectively assist U.S. manufacturers and exporters seeking to enter or expand sales overseas; increase their market share, and better equip companies to sufficiently train their employees in the art of global trade; to support the thousands of small and mid-sized manufacturers and other enterprises lacking the knowledge and resources to penetrate the international marketplace; to enable these underrepresented companies to expand sales overseas.

On July 4, 1776, 247 years ago to this day, the unanimous Declaration of Independence headed the thirteen United States Congress, the founding document of the federal republic. Today, 'The Declaration of America First Standards,' is presented to Congress, in good faith to revolutionize and stimulate the U.S. economy; as a set of standards to have government invest resources into the nation's small and medium sized businesses; particularly the manufacturing sector and related fields; and ideally, return to America's united roots of 'One nation under God;' so a government of the people, by the people, and for the people, shall not perish from the earth.

We, as business leaders, and as your constitutes, respectfully forward this 'declaration of the people' to our local Representatives of this Assembled body; the 118th United States Congress; and with rectitude of our intentions, do, in the Name, and by Authority of the United States Constitution, the supreme law of the land; solemnly publish and declare these 'America First Standards' as addressed separately; and presented with faith to be acted upon accordingly; to support businesses in all states; directly and indirectly; so that we are Absolved from all Allegiances, and with the right to oppose, renounce or deny any non-regulatory standardrization, or anti-constitutional acts, mandates or statutes, intended to influence, or coerce any form of 'global compliance' or 'rules' set forth by foreign bodies; as to ensure businesses of this nation are able to operate and establish commerce, independent of 'globalist' ideologies and their anti-American agendas, and free of all foreign oversight; as per our unalienable rights; and thereby, prey this body understands the importance of this appeal; and its decree to prioritize the interests of the American people, American businesses, and American independence, as the founding fathers intended.

Together, in firm alliance of this Declaration; as the sons and daughters of liberty; and in God we trust; with protection of divine Providence for all citizens, we, as Americans; mutually and confidently pledge to each other, our unbreakable unity, our commitment to this nation, and our sacred Honor.
